

● CLOSER to home, Blackswan Equities has issued a very positive report on **Venture Minerals (VMS)**, noting that the junior is the only ASX-listed company with JORC-compliant resources of tungsten and tin in Australia (The Chinese own or control the other JORC-compliant ones — nice going, Australia.) The report says the present resource in Tasmania is from 2.3km of strike out of the 14km-long target area.
